

# ZYLIA END USER LICENSE AGREEMENT

## FOR ZYLIA STUDIO PRO

---

This End User License Agreement is a legally binding license agreement. You need to agree to the terms of this End User License Agreement to be able to install, access or use the ZYLIA Software and other Services provided by Zylia.

By installing, accessing or using the ZYLIA Software you do not acquire any other rights beside the ones granted to you by Zylia in this End User License Agreement. The ZYLIA Software is licensed to you, which means that you are not the owner of the software. If you need any clarifications regarding the terms of the End User License Agreement you may ask Zylia for help.

To accept the terms of the ZYLIA End User License Agreement on behalf of legal entity you are required to have a full authority to act on behalf of such an entity, including authority to bind that entity.

### 1. Definitions:

- **Online Activation** – method of activating and verifying the ZYLIA Software
- **Update** – improvement in ZYLIA Software made available by Zylia to the users of ZYLIA Software
- **Support** – services provided by Zylia for the support of ZYLIA Software in case of technical problems
- **Zylia** – Zylia Spółka z ograniczoną odpowiedzialnością with its legal seat in Poznań, Poland, ul. Mostowa 27, 61-854 Poznań, KRS 0000270693, REGON 140778047, NIP PL5252380826
- **ZYLIA Software** – application named ZYLIA Studio PRO in a plugin version to be used with compatible DAW software. This EULA grants you license to use ZYLIA Studio PRO and non of the other software of Zylia. EULA does not grant a license to use any DAW software, including DAW software owned by Zylia.
- **ZYLIA Software Premium edition** - it is a ZYLIA Studio PRO Premium edition that supports Ambisonics format or features which are not included in the ZYLIA Studio FREE edition and may be used with a ZYLIA ambisonics microphone
- **ZYLIA Software FREE edition** - it is a ZYLIA Studio PRO FREE edition that does not require online activation

### 2. Ownership of the ZYLIA Studio PRO

Copyrights to the ZYLIA Software are owned by Zylia. By installing, accessing or using the ZYLIA Software you do not acquire any other rights beside the one granted to you by this license. You shall have no ownership in the ZYLIA Software, as such rights are owned by Zylia. All rights, copyrights, trademarks, patents, intellectual property rights are owned by Zylia. Zylia does not transfer any rights to you. You are authorized to use the ZYLIA Software only as a licensee in the scope set in this End User License Agreement. The ZYLIA Software is protected by applicable law, including international treaties and conventions. All rights are reserved.

### 3. Requirements

To install the ZYLIA Software you must agree to the terms and conditions of this End User License Agreement. The ZYLIA Software supports following operating systems:

- Apple – 64 bit, from OS X 10.09 to the latest
- Linux – 64 bit, Ubuntu 16.04 or higher
- Windows – 64 bit, 7, 8.1, 10, 11

The ZYLIA Software supports 64-bit Intel systems. CPU limits the processing time. 2 GB of RAM is recommended to use the ZYLIA Software. You need a minimum 2 GB of free space to install ZYLIA

Software. You will need more disk space to store data. The ZYLIA Software supports LimeLM software to activate your software (Online Activation). The LimeLM activation may happen in the background without notification for a user. You may find more information about LimeLM privacy policy at <http://wyday.com/limelm/help/activation-privacy/>. Following information may be sent to wyDay: serial number of software license, product key, time of installation, operating system name and version, and a digital fingerprint, which is a unique number that cannot be traced back to a specific user or a specific computer. You may use your ZYLIA Software only on three devices. In the case of ZYLIA Studio PRO, you need a Digital Audio Workstation that supports 19 channels in a track for ZYLIA ZM-1 signals or at least four channels for ambisonics signals. You also need a ZYLIA ZM-1 microphone connected to your computer device to use all of the features of ZYLIA Studio PRO, including recording.

#### **4. Scope of License**

Upon accepting this License Agreement, Zylia grants you a right to a non-exclusive, non-sublicensable, non-transferable license to use ZYLIA Software during the term of this End User License Agreement and a right to receive updates to ZYLIA Software as they will become available and if they will become available. Right to updates does not include a right to update to version 2.0 or newer. Right to update in case of ZYLIA Software FREE edition does not include a right to update to ZYLIA SOFTWARE Premium edition which requires separate purchase. You may not distribute ZYLIA Software to third parties, enable access to ZYLIA Software for third parties, use, transfer or export ZYLIA Software in violation of any laws or any decisions of government or governmental agency of a Member State of European Union or United States of America, reverse engineer, decompile or modify ZYLIA Software unless if in compliance with particular open source licenses delivered with ZYLIA Software. You may not publish, rent, lease or lend ZYLIA Software, make the software available for use by multiple user over a network at the same time. Reverse engineering, decompilation and disassembly of the ZYLIA Software is permitted only to the extent set by applicable law. You may choose to use a trial version or Demo Version of ZYLIA Software if the installer of ZYLIA Software allows it. Trial version will grant you a limited 7 days license to use ZYLIA Software. After 7 days the trial license will expire and ZYLIA Software will be unavailable and inaccessible. Demo Version may be used only to evaluate the software and decide whether the User wants to buy a full version of ZYLIA Software. Demo Version may be used exclusively for a non-commercial, internal use and for no other purpose. Demo Version is a restricted version that lacks some of the features available in a full version of ZYLIA Software. Files saved using Demo Version may be distorted or digitally changed in other way. You may create one backup copy of ZYLIA Software and use it to restore the software only. You may use documentation provided with ZYLIA Software.

You may choose a Subscription License instead of a standard license. Subscription License will grant you a license to use ZYLIA Software during Subscription Period. In case of a Subscription License, subject to this Agreement and subject to the payment of the applicable subscription fees, ZYLIA grants you a limited, non-exclusive and non-transferable License to use ZYLIA Software during the set Subscription Period. The Subscription Period will begin on the day of payment of subscription fees and end after a pre-set period of time. User has to pay Subscription Fees to use ZYLIA Software during the Subscription Period. Subscription will automatically renew for a new Subscription Period upon payment of the new subscription fee. You may cancel Subscription any time. Zylia may remotely disable ZYLIA Software upon expiration of Subscription License (cancellation of a subscription, end of the Subscription Period or lack of payment of the Subscription Fee).

#### **5. Error Reporting**

In case of software error you may send an automatically generated report to Zylia containing data logs or recordings. No files will be sent to Zylia without your consent. Reports may be used to solve technical problems and update ZYLIA Software.

## **6. Limited Liability and Warranty**

In any case and for all events, Zylia's liability arising out of or relating to this End User License Agreement or the use of ZYLIA Software, including without limitation on account of performance or non-performance of obligations, will not exceed the amount of 5 EURO. In no event will Zylia be liable to user for damages, including, without limitation, any incidental, consequential, special, indirect, exemplary or punitive damages or any damages arising out of or in connection with any malfunctions, regulatory non-compliance, delays, loss of data, lost profits, lost savings, interruption of service. Zylia provides ZYLIA Software and all the services "as is" and without warranties or conditions of any kind. Zylia does not guarantee or warrant that the user of the ZYLIA Software or any of the services will be uninterrupted, free of error or that Zylia will correct all ZYLIA Software errors.
